



# Corporate Law

## Practice area

These fundamental rules help build trust in Danish companies, making it attractive for both domestic and foreign companies to establish, operate, and invest in businesses in Denmark.

Moreover, certain types of companies are subject to specific requirements due to their nature, including listed companies, financial institutions, and state-owned enterprises.

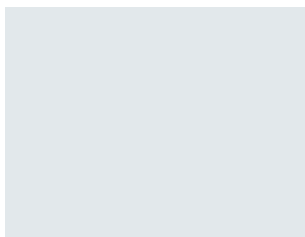

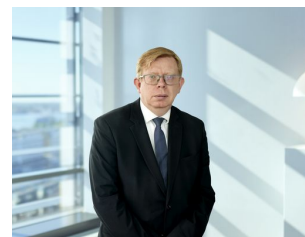

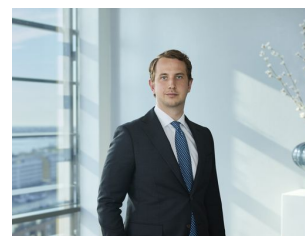
