Searches and Dawn Raids

Practice area under Corporate Criminal Law In recent years, national as well as international authorities have increasingly focused on enforcing regulation in a large number of areas, including capital market law (for example securities trading, market abuse, insider trading, price manipulation, etc.), anticorruption and anti-money laundering.
