Cases handled by Christian and his team have, for example, centred on purchase price adjustments, earn-out disputes, put/call options and claims for breach of warranty issues. Such disputes have involved a high degree of complexity, as well as expert opinions and testimony, written affidavits and various procedural and jurisdictional issues.

Christian was also part of Plesner's Corporate Finance team for many years. He has represented clients in a number of the largest and most complex transactions and privatisations in Denmark. His clients have included the Danish state, large international and domestic corporations, P/E funds and family-owned businesses.
